(Mynewsdesk) The second project located in East Sussex will again be delivered for Low Carbon, the financial investor. The project has a capacity of 8.2 MWp and construction starts in October with energisation of the project in early 2015.

The project is designed to use central inverters and poly-crystalline modules and will be connected to a 33kV overhead line.
