or />The activities envisaged by the agreement involve Enis engineers and researchers in an extensive applied research programme on several areas of interest, including the testing of new techniques for the characterization of hydrocarbon reservoirs; environmental monitoring activity finalized to the sustainability of the production of oil and gas, eco-sustainable solutions for mobility and environmental protection; the experimentation of advanced solar energy cells.

The agreement assures the ongoing activities a framework of rules governing mutual relations and the management of intellectual property and simplifies the procedural aspects. The goal is to create a portfolio of innovative solutions on the energy and environment fields, of strategic importance for Italy and Europe as a whole.
